

## **THE BASCOM LITTLE FUND**

The Bascom Little Fund provides funding for the support of new music by composers currently living in northeast Ohio. (Northeast Ohio is generally defined as extending to Sandusky on the west, and Youngstown and Steubenville to the east, Zanesville and Newark to the south, not including Columbus.) Its Declaration of Trust states that "the primary purpose for which this trust is created is the promotion through the media of concerts, publications, recordings, and otherwise, of serious and semi-popular music, newly composed and performed in or near Cleveland, Ohio."

### **GUIDELINES FOR REQUESTING FUNDS, 2008**

The deadline for 2008 proposals to the Bascom Little Fund is Tuesday, APRIL 1, 2008 (postmark). Applications postmarked after this date will not be considered at the May meeting. The Bascom Little Advisory Board meets only once each year, usually in late May or early June. Please note that The Bascom Little Fund does not provide funding for commissioning new works.

The Bascom Little Fund has supported concerts sponsored by The Cleveland Composers Guild, performances of Cleveland composers' works by the Cleveland Chamber Symphony and by the Cleveland Orchestra, the presentation of a ballet by the Tom Evert Dance Company with music by a Cleveland composer, and many chamber music concerts presenting music by Cleveland composers. The Fund has supported operas and has financed recording projects. The Fund supports musical theatre. It has also supported the performances of works by young and emerging composers in the Cleveland area. The Fund has also underwritten Not the Dead White Male Composers Hour on radio station WCLV 104.9fm for several years.

The Bascom Little Fund does not make direct grants to individuals. Applicants should be qualified, tax-exempt organizations to which donations are deductible for federal tax purposes, although some exceptions may be considered. Individuals wishing to apply for grants must be represented by tax-exempt organizations as described above.

### **The review panel will consider the following questions in evaluating all proposals:**

1. What is the purpose of the project? How will it help to promote new music in the Greater Cleveland area?
2. What are the professional qualifications and current activities of the persons involved?
3. What is the anticipated budget for this project? Has a thorough, itemized study been made of expenses such as recording, publishing, copying costs, performance expenses, promotional costs, distribution of recordings, and general administrative costs?
4. Is there a spokesman connected with the project who is qualified to promote the project to the musical community and to the general public?
5. Have the composers been properly protected in the matter of copyrights and royalties?
6. Has provision been made to ensure that programs of concerts or copies of recordings or other publications completed be furnished to The Bascom Little Fund?

### A complete application consists of the following:

4. 1 copy of supplemental material (optional). Note: 20 copies of supplemental material are not required and will not be returned!
5. Include a self-addressed, stamped envelope large enough for the return of any scores and/or recordings submitted as supplemental material
6. 1 copy of the completed Composer Acknowledgment Form for each composer involved in the project.
7. You must collate and staple items 1, 2, and 3.

### 3. LIST OF SUPPLEMENTAL MATERIAL (20 copies, if such material is included)

Provide a list of all supplemental materials included.

### 4. SUPPLEMENTAL MATERIAL (1 copy, optional)

Supplemental material may be sent in support of the application. This may include scores, copies of reviews, and other appropriate material. It is especially appropriate for scores to be included with applications involving composers whose work may not be familiar to the members of the Board of Advisors. It is also appropriate to include scores of completed compositions specific to the project. Compact discs may be sent as documentation, but equipment for playback of these recordings generally will not be available at the meeting.
